**91% of members participating in the survey were current members of EOCRN and 9% responding were not. There were 34 total participants.**

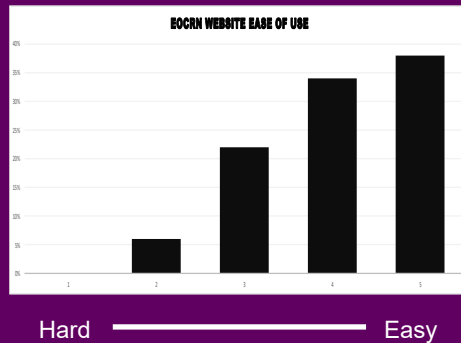
### What People Like About EOCRN

### Community Spotlight: Eastern Oregon Coordinated Care Organization Supporting Health for All Through Reinvestment (SHARE)

Eastern Oregon Coordinated Care Organization (EOCCO) is pleased to announce that applications for the **Supporting Health for All through REinvestment (SHARE) Initiative** are now open. The Supporting Health for All through REinvestment (SHARE) Initiative aims to address social determinants of health while improving housing in Eastern Oregon. This grant opportunity allows applicants to propose “shovel-ready” housing projects, which may include: contributions to affordable housing development; permanent supportive housing; rapid re-housing programs; transitional housing; shelters; asset building; building renovations; improving accessibility; rental assistance; individual assistance with housing applications; and efforts to combat discrimination in housing communities. The application for this grant is due **August 9<sup>th</sup>**.

**Applicants:** Eligible applicants include any interested organization, local government, tribal government, or collaborative that delivers Social Determinants of Health and Equity (SDOH-E) related services, programs, or policies in Eastern Oregon. Applicants must have the ability to complete their proposed project in Eastern Oregon within 24 months of the October 2021 award start date.

**Project Focus:** Projects must focus on providing housing-related services and/or supports for EOCCO members. Proposals that help EOCCO members find, access, and maintain safe and affordable housing can be project-based (at the community level) or tenant-based (at the individual member level).

**Budget & Funding:** Up to \$310,000 is available in total funding, and up to four applications may be selected.
